I hereby acknowledge that I am aware of the risks and hazards associated with or related to this activity. The risks and hazards include, but are not limited to:

- Injuries from executing strenuous and demanding physical techniques in basketball, soccer, football or any other sport;
- Injuries from dry-land training including weights, running, and massage;
- Injuries from grass, turf and other surfaces including bacterial infections and rashes;
- Injuries resulting from falls to the ground due to uneven or irregular terrain or surfaces;
- Injuries from collisions with walls and/or any sport equipment;
- Injuries resulting from failure to properly use any piece of equipment or the mechanical failure of the equipment;
- Spinal cord injuries which may render me permanently paralyzed;
- Injuries from extreme weather conditions which may result in heatstroke, sunstroke or hypothermia;
- Injuries from contact, colliding or being struck by other participants, spectators, equipment or vehicles;
- Injuries resulting from vigorous physical exertion and strenuous cardiovascular workouts;
- Injuries from exerting and stretching various muscle groups; and
- Travel to and from competitive events and associated non-competitive events which are an integral part of the organization's activities.
- Injuries sustained in basketball, soccer, football or any other sport can be severe;
- Participant may experience anxiety while challenging oneself during the activities;
- Participant may come into close contact with others, including the possibility of accidental and unexpected contact;
