We are pleased to announce that the election process at MIC has been completed on February 1, 2009. Only 23 Members participated and 5 Observers attended the Election. Since all the candidates were elected unopposed, voting was done to elect 3 directors for 2 years and 2 directors for 1 year in accordance with article 5.2 of the MIC Constitution and By-Laws.

Highest vote getter shall be elected to hold office for a term of two years. President & Treasurer were elected based on vote received. However, VP, Secretary and Joint Secretary were elected by draw.
